AWARDS

Best of Show - \$1,500.

Cash and Merchandise awards will total approximately \$7,000.00.

Winners will be announced at the opening reception.

ELIGIBILITY

Open to all U.S. artists, 18 years and older. All work must be original in concept, executed by the artist within the last three years, with at least 80% of the image area in soft pastel. No oil pastels. Compositions taken from published material will not be considered original. Work produced under supervision is ineligible. Work previously exhibited in any CPP Exhibition is not eligible. All work must be for sale. CPP will retain 25% commission on all sales.

FRAMING REQUIREMENTS

Minimum image size is 12" x 12". Maximum framed size is 42 inches in any direction. All work must be professionally framed and ready to be hung. No screw eyes. No sawtooth hangers. Plexiglas strongly recommended for shipped works. Glass at artist's own risk.

IMAGE REQUIREMENTS

Each artist may submit a maximum of 3 images, on one CD, with each CD labeled with artist's name, entry number, title, and image size.
Accepted formats: jpeg.

Format the image with a resolution of 300 dpi and the longest side at no more than 1800 pixels.

Only the painted image should show. Label the image with the title, artist's last name and the entry number. Example: **thelandscape.smith.01.jpg**.

CDs will not be returned.

ENTRY FEES

Current members: \$30.00, up to 3 images.

Non-members: \$40.00, up to 3 images.

Check payable to the Chicago Pastel Painters

DELIVERY

Accepted artists will receive detailed information about hand-delivery, shipping and handling, and exhibition labels. A fee of \$40.00 will be charged to handle shipped work.

WORKSHOP

In conjunction with the exhibition, Desmond O'Hagan, MPSA, will conduct a three-day workshop September 16 - 18, 2011, in Chicago, Illinois.
